The Faith Leaders of Color Coalition (flocc) is a multifaith national organization dedicated to advocating for justice, equity, and interrogation into the American Capital Punishment system.

The Faith Leaders of Color Coalition (flocc) allows space for Black and Indigenous faith leaders to build community, ask questions, take action, and collaborate with other movement leaders working to end the system of death in America.

The Faith Leaders of Color Coalition (flocc) was born out of a cohort in 2021 when policy leaders, advocates, activists, lawyers, academics, and faith leaders desired to extend access of policy, legal, and execution information directly to Black and Indigenous pastors/clergy. This initiative which started as 21 people on a Zoom call, has now grown into an organization of more than 700+ supporters, friends, families and partners.

flocc's D.N.A.

1. Advocate for Policies to Eliminate the use of the capital punishment system:

flocc will work to eliminate the capital punishment system, addressing racial discrimination, intellectual disability, wrongful convictions, felony murder, innocence claims and inhumane conditions on death row.

2. Empower Faith Leaders:

flocc will educate and empower Black and Indigenous clergy to use their moral authority, influence and spiritual teachings to advocate for an end to state-sanctioned death in their respective states and nation.

3. Cast Vision:

flocc aims to educate the public about the injustices and uneven applications when death sentences are applied, particularly with white victims. flocc will introduce ways to hold district attorneys and municipalities accountable for authentic public safety.

4. Promote Healing:

flocc recognizes the profound trauma inflicted by the death penalty on both victims' families and those involved in the system. The coalition will work toward healing, reconciliation and restoration.

MARCH 2025

New Orleans carried out their first execution of Jessie Lee Hoffman in almost 15 years by nitrogen gas. The execution came after lawyers sought a last-minute reprieve- arguing nitrogen hypoxia equals cruel and unusual punishment and is prohibited under the 8th Amendment. After this tireless fight, FLOCC along with PJI & NAACP Louisiana offered a prayer brunch for the faith community educating them about the role faith plays in stop execution campaigns.



Legislation



HB123 - Georgia

MAY 2025

After years of legislative advocacy and on-the-ground action in Georgia, HB123, a landmark bill that lowers the standard of proof for individuals with intellectual disabilities facing death sentences was signed into law. FLOCC played an active role in bringing Georgia faith leaders and lawmakers together, creating the space for honest dialogue about why this bill was not only necessary but morally urgent.

HB123 represents an essential first step in addressing the deeply flawed capital punishment system in our state and ensuring that those with intellectual disabilities are protected from wrongful execution. We extend our heartfelt thanks to the many state officials, legislators, and advocates who carried, championed, and supported this bill from start to finish.

Prayer & Policy


FEBRUARY 2025

Months before HB123 was signed into law, our friends at GFADP organized a powerful lobby day that brought together multi-faith leaders standing in solidarity to bear witness and advocate for the bill. The theme was “Ring Around the Capitol. For supporters unable to be there in person, phone calls were made around the clock. For those able to gather physically, we joined hands in a circle to pray for the state of Georgia and for those entrusted with making the highest decisions in our government.

On that day, prayer and policy moved hand in hand, drawing urgent attention to the cruel and inhumane practice of executing individuals with intellectual disabilities and reinforcing the moral call confront it head on.


As advocacy for Tremane Wood intensified, FLOCC partnered with conservative strategists who indicated that Governor Stitt sought to define his gubernatorial legacy around principles of fairness and faith. With this insight, within a two-week period, FLOCC mobilized and secured more than 300 signatures from pastors and faith leaders urging the Governor of Oklahoma to stand with them and grant clemency to Tremane Wood.

One week before an execution date was set, the Oklahoma Board of Pardons and Paroles formally recommended clemency in Tremane Wood's case. This effort was launched to press the governor to follow the board's recommendation. The signed letter was hand-delivered directly to the governor's office three days before the scheduled execution.

Tremane Wood

NOVEMBER 2025

November 13th, 2025 Tremane Wood was granted clemency and saved from execution by the state of Oklahoma. For two years, floc has led national advocacy and strategy efforts to stop the execution of Tremane Wood who has been on Oklahoma's death row for more than 20 years for felony murder. Amanda Bass Castro-Alves brilliantly led Tremane's legal team and trusted floc to coordinate efforts with influential faith partners and national voice to contribute to the growing public pressure on his case. We were overwhelmingly excited and relieved by his clemency!

Faith Groups Join Other Death Penalty Opponents in New Campaign

(RNS) — More than 50 faith, civil rights, and other organizations launched a joint initiative to oppose the death penalty in the United States as the groups' leaders say they have been alarmed by increases in its use over the past year.

Katie Geneva Cannon Center for Womanist Leadership 2026 Fellowship



Our Founder & National Director, Joia Erin Thornton, was selected to be a member of 2026 Womanist Leadership Fellowship. The Katie Geneva Cannon Womanist Fellowship is a leadership development program rooted in the legacy of Rev. Dr. Katie Geneva Cannon, a pioneering theologian, ethicist, and the first African American woman ordained in the Presbyterian Church (U.S.A.). She was also a foundational voice in womanist theology, which centers the experiences and leadership of Black women in theological scholarship, ethics, and ministry.

This fellowship will take place over the entire 2026 fiscal year and will allow our founder access to courses like Womanist Theology & Afrofuturism, Womanist Biblical Interpretation and other course to certify her as a womanist theologian. More importantly, this fellowship support Black women in leadership through intersectional spaces like health, justice, education and technology.

FICPFM, Formerly Incarcerated People & Families Movement



In 2025, we passed critical legislation in the state of Georgia that resulted in a law that lowers the standard of proof for individuals living with intellectual disabilities facing capital cases to prove their condition more efficiently.
